Credit account customer must comply with the following requirements. Failure to comply with these requirements may result in the loss of credit account and/or ability to use the McKenzie County Landfill.

- Pay all invoices in full within 30 days of receipt or pay additional fees.
- Follow Landfill disposal procedures including:
  - Tarp open topped roll-offs and trailers.
  - Follow scale house “weigh-in and weigh-out” procedures.
  - No dumping of wastes not accepted by the Landfill.
- Be respectful of County staff and other customers using the Landfill facilities.
- Properly dispose of all waste generated by the credit account customer within McKenzie County, including hazardous waste that may need to be disposed of out of state.
