## OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS MCKENZIE COUNTY, NORTH DAKOTA

## **February 6, 2024**

The Board of Commissioners of McKenzie County, North Dakota met at the Commissioners Room at the McKenzie County Courthouse in Watford City, North Dakota on February 6, 2024. Present: Commissioners Clint Wold, Howdy Lawlar, Kathy Skarda, Joel Brown, and Craig Hystad. Also present Auditor/Treasurer Johnsrud and State's Attorney Skarda. Chairman Lawlar called the meeting to order at 9:00 a.m. with the Pledge of Allegiance.

Moved by Skarda, seconded by Wold, to approve the agenda as amended to include the Grayson Mills AFEs received. All voting aye, motion carried.

Moved by Skarda, seconded by Hystad, to approve the January 2024 minutes as presented. All voting aye, motion carried.

Discussion was held on the bills presented for payment. Moved by Brown, seconded by Skarda, to approve the bills as presented. All voting aye, motion carried.

Moved by Brown, seconded by Skarda, to approve the Commission Consent Agenda Items 1-6 as presented. All voting aye, motion carried. Items approved: 1. Set Public Hearing – Abatement Applications 4551, 4553-4554 – February 20, 2024 at 10:00 a.m.; 2. Approve Out of State Travel - Extension 4-H Junior Leaders to Sidney February 18, 2024; 3. Designate McKenzie County Official Depositories - First International Bank & Trust; BNC Bank; Cornerstone Bank; Dakota West Credit Union, Bank of North Dakota; Bravera Bank; 4. Approve Appointments for McKenzie County Re-Organization, Annexation & Dissolution Board; 5. Approve Out of State Travel - ESRI User Conference in San Diego July 14-19<sup>th</sup>; 6. Approve Raffle Permit – McKenzie County Ducks Unlimited – March 23, 2024.

Discussion was held on upcoming NDIC, PSC, NDDOH, and other public hearings.

Landfill Director/911 Coordinator Schreiber provided an update on the 911 system and discussions that are ongoing with various stakeholders. Schreiber also presented a Memorandum of Understanding with the MHA Nation for 911 addressing. Moved by Skarda, seconded by Hystad, to approve the MOU and authorize the chairman to sign. All voting aye, motion carried.

Discussion was held on the Weed Control trailers that were offered for sale by sealed bid. One bid was received and the Weed Board would like to rebid the second trailer with the addition of a large ad with photos in the newspaper. Weed Officer Higgins will work with the Auditor/Treasurer's Office on the publication and bid opening

schedule. Moved by Skarda, seconded by Hystad, to award the 16-foot PJ trailer bid to Justin Johnsrud, highest bidder, and to authorize the rebidding for the 14-foot PJ trailer. All voting aye, motion carried.

Economic Development Director Stenberg requested a Cooperative Work Experience (CWE) High School student for the 2024-2025 school year within his department. Discussion was held about other departments that may wish to have a student and the need for a well thought out program of learning and meaningful work for the student. Moved by Skarda, seconded by Brown, to approve the CWE student for Economic Development for the 2024-2025 school year. All voting aye, motion carried.

Stenberg and HR Director Norby provided an update on the County's social media and online presence. They are continuing to work together to understand the needs and have further discussions about plans to cleanup and write policies. Stenberg requested the specific creation of a tourism Facebook and Instagram account for promotion tourism in the County. Moved by Skarda, seconded by Wold, to approve the creation of the Tourism Facebook and Instagram accounts as requested. All voting aye, motion carried.

At 10:10 a.m. a bid opening was held on dump truck and excavators for the Road & Bridge Department.

Norby provided information to the Board regarding performance reviews of department heads that directly report to the Board and offered information on how other counties handle this process. Board direction was for department heads seeking input to reach out to individual commissioners to schedule one-on-one meetings, recognizing that official direction can only come from the Board as a whole during a public meeting.

MCSO Chief Deputy Ficken discussed with the Board the vehicles ordered in the fall of 2023 for 2024 delivery. Ficken stated the vehicles had been delivered and requested direction on how many the County would be purchasing and what vehicles would be traded in. Fleet Manager Shannon also provided information on departments that requested a vehicle. Moved by Skarda, seconded by Brown, to approve the purchase of the 12 vehicles as presented, to retain Units 68, 81, and 84 and trade in all other presented, and decide which department would receive the 2024 Ford F250 at the next Board meeting. All voting aye, motion carried.

Ag Expo Director Kubal provided a general update on the status of the facility, events upcoming, and issues that were being addressed.

Moved by Skarda, seconded by Hystad, to release a bid package for a new mini loader for the Ag Expo and to open bids during a Board meeting. All voting aye, motion carried.

Moved by Lawlar, seconded by Brown, to approve the purchase of the bedding guards as presented for a total cost of \$10,491. All voting aye, motion carried.

Moved by Wold, seconded by Hystad, to approve the purchase of an additional 644 Loader bucket and the associated budget amendment. All voting aye, motion carried.

MCWRD Director Perkins provided information to the Board on the 2<sup>nd</sup> river crossing project and an EPA lead and copper survey that is underway. Perkins provided information on a joint powers agreement for the river crossing, but the Board requested additional time to review the document. Perkins stated AE2S was hired by the State of North Dakota to perform the EPA lead and copper survey, which requires an inventory of all service line materials in the water system. Perkins stated it is very intrusive to ask homeowners regarding the material within their homes, but that if the survey was not completed, it would be assume the internal pipe materials contained lead. Perkins stated only those customers on the rural water system need to respond to the survey when they receive the letter in the mail.

Library Director Anguiano provided the 2023 Annual Report of the Library. Anguiano reported it was a positive year for the Library with growth in several areas and they are continuing their outreach efforts in 2024, including additional bookmobile stops in the County.

Moved by Brown, seconded by Wold, to approve the release of the Group 1 and Group 2 Structure Replacements project bids, with bids to be opened outside of a Board meeting as requested. All voting aye, motion carried.

Moved by Hystad, seconded by Skarda, to approve NDDOT Structure Replacement Contract 38220262 Amendment as presented and authorize the chairman to sign. All voting aye, motion carried.

Moved by Hystad, seconded by Skarda, to approve NDDOT Structure Replacements Contract 38240093 Amendment as presented and authorize the chairman to sign. All voting ave, motion carried.

Moved by Skarda, seconded by Brown, to approve Change Order 1 for the County Road 30 Phase II project as presented in the amount of \$77,468.50 and authorize the chairman to sign. Engineer Demars stated there was a change in approach pipe sizes and the critical path method schedule. All voting aye, motion carried.

Moved by Hystad, seconded by Wold, to approve the Final Design Amendment #3 for the County Road 30 Phase II project with KLJ in the amount of \$158,300 and authorize the chairman to sign. All voting aye, motion carried.

Demars updated the Board on signage at the intersection of Highway 1806 and County Road 10. Demars stated the department will continue to review and monitor the safety of that intersection.

Brown discussed with the Board recent AFEs that were received from Grayson Mills for minerals owned by the County. Brown requested to perform and economic analysis and will provide that information to the Board at the next meeting.

Moved by Skarda, seconded by Wold, to approve the payment for meals for the HazMat team as presented by Emergency Manager Jappe. All voting aye, motion carried.

Moved by Wold, seconded by Brown, to approve the fuel island bids, total of \$103,983.95 for the Rawson Shop as presented. All voting aye, motion carried.

Facilities Manager Loughnan requested direction from the Board on a fire suppression/detection system at the Rawson Shop. The Board requested additional information on cost estimates and insurance savings and for Loughnan to return with that information.

Discussion was held on #2-22CUP – Brady's Towing Revocation of CUP item. Attorney Jordan Everett for the Beyers appeared and stated Brady's Towing was not able to secure a bond and due to the property being a former well site, where reclamation was waived by the former owner, the property likely would never be reclaimed. Everett stated that if the bond requirement stays for the CUP, Brady's Towing would have to shut down their operation and move somewhere out of the County where zoning regulations were different. Nathan Hill, First International Bank & Trust Financial Advisor, stated the specific use of the property was not the reason the bond wasn't approved. Hill stated bonds have strict financial constraints due to being similar to an unsecured loan, which can be risky for the lender depending on the financials of the company. Discussion was held on whether or not Brady's Towing would ever be able to receive a bond. Skarda asked if all other requirements in the CUP had been met, other than the bond. Brady Beyers stated yes, but that the trees previously planted as a requirement had died and needed to be replaced. Discussion was held on whether or not to send the item back to the Planning & Zoning Board for their recommendation. Skarda and Hystad, both P&Z Board members, requested to have the decision made by the Board of County Commissioners, not the P&Z Board. Discussion was held on exemptions and possible downstream repercussions. Moved by Brown, seconded by Wold, to grant an extension of the bonding requirement for a period of one year due to the belief the bonding requirement may be met with an extension of time and due to the unique location and characteristics of the property. A review will be done by Planning & Zoning staff this summer and provided to the Board. P&Z Director Kimpel requested an update at least every three months. Beyers and Everett stated they would work to provide monthly updates. All voting aye, motion carried.

Brown left the meeting at 1:29 p.m.

Moved by Hystad, seconded by Skarda, to approve the out of state travel for one planner to National Planning Conference in Minneapolis, MN with a report of what was learned upon return. All voting aye with Brown absent, motion carried.

Moved by Skarda, seconded by Hystad, to accept the 2022 Audit documents as presented. All voting aye with Brown absent, motion carried.

Moved by Lawlar, seconded by Skarda, to approve the 2025 Budget Calendar as presented and require departments to meet with the Auditor/Treasurer no later than May 24, 2024, regarding their proposed 2025 budgets. All voting aye with Brown absent, motion carried.

Moved by Skarda, seconded by Hystad, to approve the 2023 budget amendments as presented in the Budget to Actual report by Auditor/Treasurer Johnsrud due to unanticipated expenses or other increases to costs: increase the Auditor/Treasurer budget from \$682,721 to \$693,511; increase the Supt of Schools budget from \$95,723 to \$127,316; increase the Landfill budget from \$2,391,020 to \$2,972,790; increase the Coroner budget from \$40,000 to \$52,664; increase the Disaster Emergency budget from \$235,247 to \$241,957; increase the Ag Expo budget from \$0 to \$2,214,688; increase the Budget Contributions budget from \$1,049,887 to \$1,083 176; increase the Transfers to Other funds budget from \$57,925,000 to \$76.658,500; increase the HV1505 ARPA budget from \$0 to \$2,935,323; increase the County Park budget from \$275,427 to \$407,939; increase the JDA budget from \$1,364,613 to \$16,883,988; increase the Self-Insurance budget from \$4,351,000 to \$4,369,818; increase the Doc Preservation budget from \$76,000 to \$155,081; increase the Haz Chem budget from \$47,200 to \$105,080; increase the Health Unit budget from \$383,670 to \$433,368; increase the Historical Society budget from \$89,675 to \$102,045. All voting aye with Brown absent, motion carried.

The meeting recessed at 1:47 p.m. until February 20, 2024, at 9:00 a.m.

## February 20, 2024

The Board of Commissioners of McKenzie County, North Dakota met at the Commissioners Room at the McKenzie County Courthouse in Watford City, North Dakota on February 20, 2024. Present: Commissioners Howdy Lawlar, Joel Brown, Clint Wold, and Kathy Skarda (by phone). Also present Auditor/Treasurer Johnsrud and State's Attorney Skarda. Absent: Commissioner Craig Hystad. Chairman Lawlar called the meeting to order at 9:00 a.m. with the Pledge of Allegiance.

Moved by Brown, seconded by Wold, to approve the agenda as amended to include an improvement plan for Hillside Court and the MOU for Cooperating Agency Status with Dakota Prairie Grasslands. All voting aye, motion carried.

Discussion was held on the informational reports provided.

Discussion was held on the bills presented for payment. Moved by Brown, seconded by Wold, to approve the bills as presented. All voting aye, motion carried.

Moved by Skarda, seconded by Brown, to accept the Treasurer's Report for the period ending January 31, 2024, as presented. All voting aye, motion carried.

Moved by Brown, seconded by Wold, to approve Items 1-4 on the Commission Consent Agenda as presented. All voting aye, motion carried. Items approved: 1. Set Public Hearing – Section Line Closure Request Sections 4&9, T153N R95W – March 19, 2024 at 10:00a.m.; 2. Set Public Hearing – Abatement Applications 4549-4550, 4552 – March 5, 2024 at 10:00a.m.; 3. Approve Gaming Site Authorization – Dunn Count Fair Association at Long X Saloon; 4. Approve Out of State Travel – MCSO CTK Evidence-Based Interview and Interrogation – West Des Moines, IA – March 18-20, 2024.

Moved by Brown, seconded by Wold, to approve Items 1-3 on the Planning & Zoning Consent Agenda as presented. All voting aye, motion carried. Items approved: 1. #01-24CUP Central Specialties – Approved. Applicant is requesting a Conditional Use Permit to provide temporary employee housing sites to their employees.; 2. #2-24CUP Basin Electric – Approved with added condition #9, If the PSC has any specific concerns, we will include them as added conditions on this CUP. Applicant is requesting a conditional use permit to run a 10.9-mile 345KV line from the McKenzie County Line to the Basin Electric property near Johnson's Corner; 3. Applic#01-24ZCZC Hess ND Pipeline – Approved Applicant is requesting a Zone Change from Agriculture to Industrial to accommodate a PSC regulated Compressor Station.

P&Z Director Kimpel introduced Lindsay Brown, Stantec, to the Board. Stantec is the consultant for the Brownfields Grant the County received. Brown provided information on the project, next steps, and Stantec's role in the process. Lawlar asked for an update of possible locations once the survey is completed.

P&Z Attorney Johnson discussed with the Board reclamation at the Great American Lodge site. Johnson provided background information on the escrow funds that were transferred to the County, the agreement, and how the process will work in order to withdraw funds from the account. Johnson requested the Board approve bidding out the project once landowner's consent has been obtained. Johnson stated he is not concerned that the landowners with object to the clean up work and that it is the responsibility of the landowner to bring the property into compliance. Moved by Lawlar, seconded by Brown, to advertise the Great American Lodge reclamation project for bids, contingent on receiving written consent from the landowners or their attorney and to open bids for the project within a future Board meeting. All voting aye, motion carried.

MCSO Lt. Martinez discussed with the Board the process for receipting restitution checks for a specific case in which the company requested restitution be paid to McKenzie County. Martinez stated the Sheriff's Office wanted to use the funds to

purchase equipment in the future but funds received would be sporadic and of unknown amounts. Board consensus was to provide the checks to the Auditor/Treasurer's Office who will determine the manner in which they will be recorded and requested the line item be added to the monthly Treasurer Reports.

Moved by Brown, seconded by Wold, to post the Library Director position as presented by HR Director Norby. Norby recommended not appointing an interim director at this time as there is already an Assistant Director who can handle the day-to-day operations with the same authority as the director position. All voting aye, motion carried. Moved by Brown, seconded by Wold, to appoint Assistant Director Joy as an approved Library camera access user until a director is hired. All voting aye, motion carried.

At 10:00 a.m. a public hearing was held on abatement applications. No persons from the public were present. Moved by Brown, seconded by Wold, to approve Abatement Applications 4551 and 4553-4554 as presented. All voting aye, motion carried.

Randy Stevenson, landowner along 122<sup>nd</sup> Ave NW, approached the Board regarding the project and requested fencing be added along both sides of the road. Lawlar asked if the areas were already currently fenced and Stevenson replied no. Lawlar expressed concern about setting a precedence for adding fence where no fence was currently, which would be additional compensation received by some landowners. Demars stated the goal of the project was to improve safety, but there is currently open grazing along that road, and it was not a goal of the project to remove open grazing. Demars explained the right-of-way process including the payments for permanent easement (\$2,000/acre) and temporary easements (\$200/acre) paid to landowners on all County projects. Brown stated the Board wants to say yes to every request it hears, but also can't show favoritism, which can be a hard balance to maintain.

Demars updated the Board regarding an open house that will be held on March 6 in the Board Room regarding the 24<sup>th</sup> Ave SW Reconstruction project. Demars stated there will be a formal presentation at 6:00 p.m. and the open house following until 7:30 p.m.

Economic Development Director Stenberg requested approval for out of state travel to tech centers in Hobbs, NM and Ponca City, OK. Stenberg invited any member of the Board interested to also travel to the locations which have both experienced challenges or changes in economic growth. Members of the schools, Williston State College, JDA Board, and others have also been invited to attend, with each entity paying their own participant costs. Moved by Lawlar, seconded by Wold, to approve the out of state travel request for Stenberg and up to two commissioners wishing to attend, including a car rental if needed. Estimated cost is \$1700/person. All voting aye, motion carried. Lawlar requested a report back to the Board after the travel was complete.

Facilities Administrator Schroeder and Supervisor Loughnan discussed the Courthouse Cooling System with the Board. Loughnan stated the ground loop system is not sufficient to appropriately cool the building and was not expanded when the Courthouse addition was completed. Andrew Vlasak, Trane, was present to answer questions and provide information on the Omnia bid provided. Vlasak stated the project would be completed prior to the Fall. Discussion was held on the risk to the current system if this work was not completed. Moved by Skarda, seconded by Wold, to approve the Courthouse cooling system work as presented on Omnia bid in the amount of \$354,690.00 and the associated budget amendment. All voting aye, motion carried.

Moved by Wold, seconded by Skarda, to approve the updated bid from O'Day Equipment, LLC for the Rawson Shop fuel island project in the amount of \$79,156.01, which removed the crane costs, and authorize the chairman to sign. All voting aye, motion carried.

Schroeder requested to move the five Facility Technicians positions to four 10-hour schedules to ensure coverage during the day when employees are in the buildings. Schroeder stated the goal was to reduce overtime costs and ensure better coverage of the buildings. Moved by Wold, seconded by Brown, to approve the schedule change to 10-hour shifts for the five Facility Technician positions as presented. Brown asked to revisit the topic in a couple of months with information on operational coverage and overtime costs to see if the change has met the goals. All voting aye, motion carried.

Ag Expo Director Kubal provided an update on the Ag Expo facility. Kubal updated on the past and upcoming events, table shipments, and HVAC repairs.

Moved by Brown, seconded by Wold, to approve the Ag Expo Billboard Change Order and Contract Extension with FCI Constructors as presented for a total cost of \$823,768 plus an estimated \$27,000 for MEC electrical costs and authorize the chairman to sign. All voting aye, motion carried.

Fleet Manager Shannon requested to sell Unit 111, 2003 Ford F350 with flatbed trailer, by sealed bid and to set a minimum price of \$5,000. Moved by Wold, seconded by Brown, to approve releasing a sealed bid for the sale of the 2003 Ford F350 with a minimum price of \$5,000. All voting aye, motion carried.

The bid results for the haul trucks and excavator were presented, both rental and purchase options. Shannon and Road Superintendent Northrup requested to rent the equipment at this time and return after 5 months with a recommendation on whether or not to purchase the units. Shannon stated the bids received from Tractor & Equipment did not meet the bid specifications. Moved by Lawlar, seconded by Brown, to approve the rental of two haul trucks from RDO at a cost of \$165,000 for six months and to approve the renal of one excavator from RDO at a cost of \$97,500 for six months as presented. All voting aye, motion carried.

Moved by Brown, seconded by Wold, to appoint State's Attorney Skarda as the point of contact for the Memorandum of Understanding with USFS Dakota Prairie Grasslands for the Travel Management Plan and approve signature of the MOU once SA Skarda has reviewed and approved of the final document. All voting aye, motion carried.

Wold requested to pursue an evaluation of the Hillside Court property for improving drainage at the facility. SA Skarda recommended information be obtained from Brosz Engineering regarding the cost of preparing a scope of work and to return with that information at the next meeting to determine whether or not an RFP is required.

Brown presented an analysis on the Grayson Mill Energy well documents that County received. The analysis indicated the best economical option for the County was to participate in the wells based on the location, operator, and potential returns. Moved by Lawlar, seconded by Wold, to participate in and consent to the Holm 150-99-13-24-3H, Scott 13-24 XW 1H, and Holm 150-99-13-24-2H rework operations as presented and authorize the chairman to sign the documents. All voting aye, motion carried.

The meeting adjourned at 11:56 a.m. until March 5, 2024, at 9:00 a.m.
