OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS MCKENZIE COUNTY, NORTH DAKOTA

January 2, 2024

The Board of Commissioners of McKenzie County, North Dakota met at the Commissioners Room at the McKenzie County Courthouse in Watford City, North Dakota on January 2, 2024. Present: Commissioners Clint Wold, Howdy Lawlar, Kathy Skarda, Joel Brown, and Craig Hystad. Also present Auditor/Treasurer Johnsrud and State's Attorney Skarda. Chairman Lawlar called the meeting to order at 9:00 a.m. with the Pledge of Allegiance.

Moved by Skarda, seconded by Hystad, to approve the agenda as presented. All voting aye, motion carried.

Moved by Hystad, seconded by Wold, to approve the December 2023 minutes as presented. All voting aye, motion carried.

Discussion was held on the bills presented for payment. Moved by Skarda, seconded by Hystad, to approve the bills as presented. All voting aye, motion carried.

Moved by Brown, seconded by Skarda, to approve the Commission Consent Agenda Items 1-4 as presented. All voting aye, motion carried. Items approved: 1. Approve Publication of 2024 Salaries in Official County Newspaper; 2. Approve & Authorize Signature – Updated Election Agreements with Cities of Arnegard and Alexander; 3. Approve & Authorize Signature – TY Pickett Contract Renewal; 4. Approve & Authorize Signature – Central Specialties, Inc. Agreement – CR30 Phase II Project.

Discussion was held on upcoming NDIC, PSC, NDDOH, and other public hearings.

Library Director Anguiano requested to change the vendor being utilized for the security cameras at the Library and move them to the same vendor as other County facilities. The new vendor would also be local and able to provide more efficient service when needed. Skarda asked if this had been approved by the Library Board and Anguiano stated it would be discussed at their next meeting. Moved by Wold, seconded by Skarda, to approve the Library camera vendor change as requested pending the approval of the Library Board. All voting aye, motion carried.

Ag Expo Director Kubal provide an update of past and future events at the Ag Expo, as well as updates to the damaged tables, HVAC testing, and sound upgrades. Discussion was also held on renting the facility for motocross practices for fundamentals, no racing. Discussion was held on minors who may be accompanying non-parental/non-guardian adults and if liability waivers would be needed. State's

Attorney Skarda will prepare a waiver form for use. Board consensus was to approve the facility rental for this use, including the liability waivers as developed by SA Skarda.

Engineer Demars presented a contract and task order for right-of-way services with Northwestern Land LLC due to the pending retirement of the current right-of-way agent utilized through HDR. Demars stated the task order would cover the 24th Ave project. Skarda asked about public input meetings for that project, which the rest of the Board agreed would be beneficial to all parties. Demars stated she would work to schedule a public input meeting for the 24th Ave project. Moved by Skarda, seconded by Wold, to approve and authorize signature on the Multiple Project Agreement for Contractor Services and the 24th Ave SW Reconstruction Project Task Order with Northwestern Land, LLC, as presented not to exceed \$25,000. All voting aye, motion carried.

Moved by Hystad, seconded by Wold, to approve exceeding Task Order 5 with HDR by up to \$10,000 as presented for right-of-way agent services. This would allow the retiring agent to complete his work. All voting aye, motion carried.

Demars presented example documentation that is being sent to McKenzie County organized townships regarding road certifications, maintenance of township roads, and any right of way permitting needs. Demars is also requesting townships meet with herself and Road Superintendent Northrop to discuss any questions. Skarda asked to receive an update on the information that was provided back from the townships when compiled.

Moved by Hystad, seconded by Wold, to approve and authorize signature of the American Engineering Testing, Inc., proposal for a pavement testing study in the amount of \$146,792 contingent upon the proposed schedule and SA Skarda's final approval of the contract language. All voting aye, motion carried.

Fleet Manager Shannon and Road Superintendent Northrop requested to release bids for two haul trucks and one excavator. Moved by Brown, seconded by Skarda, to release the bid specifications as presented for one excavator and two haul trucks with bids to be opened during the February 6 Board meeting. All voting aye, motion carried.

Discussion was held on the Rawson Shop fuel island and fuel tanks. The diesel tank is currently set but new requirements from the State will not allow the fuel pumps to be placed on the pad where planned and a request to purchase an unleaded tank. The Board asked questions about the quote pricing received, whether a new diesel tank would allow relocation of the pumps back to the original pad, and costs associated with other options. The Board requested additional information be gathered and brought back to a future meeting.

Auditor/Treasurer Johnsrud provided an update on staffing in her office and the temporary position that was authorized, but not filled, for 2023. Johnsrud requested a temporary employee in 2024, no budget amendment would be needed at this time.

Moved by Brown, seconded by Hystad, to approve the Auditor/Treasurer's request for a temporary employee in 2024. All voting aye, motion carried.

Johnsrud requested the Board freeze her salary at its current step and amount until re-elected to the position. Johnsrud stated she is fairly compensated for her position with her colleagues in the region and statewide and expressed her desire to not receive cost-of-living or other adjustments provided to employees as providing information to the Board regarding these decisions would personally benefit her. Moved by Skarda, seconded by Brown, to honor the request of Auditor/Treasurer Johnsrud and to freeze her salary at its current step and amount until and if she is re-elected to her position. All voting aye, motion carried.

Skarda provided information on an upcoming public meeting on ND Cloud Modification Planning. The meeting is open to the public and will occur beginning at 1:15 p.m. on February 6 in the Training Room of the Williams County Administration Building, 206 E Broadway, Williston, ND.

The meeting recessed at 10:53 a.m. until January 16, 2024, at 9:00 a.m.

January 16, 2024

The Board of Commissioners of McKenzie County, North Dakota met at the Commissioners Room at the McKenzie County Courthouse in Watford City, North Dakota on January 16, 2024. Present: Commissioners Howdy Lawlar, Joel Brown, Craig Hystad, Clint Wold, and Kathy Skarda. Also present Auditor/Treasurer Johnsrud and State's Attorney Skarda. Chairman Lawlar called the meeting to order at 9:00 a.m. with the Pledge of Allegiance.

Moved by Skarda, seconded by Hystad, to approve the agenda as presented. All voting aye, motion carried.

Discussion was held on the informational reports provided. The Board requested a report on current County social media accounts at their next meeting.

Discussion was held on the bills presented for payment. Moved by Skarda, seconded by Wold, to approve the bills as presented. All voting aye, motion carried.

Moved by Skarda, seconded by Brown, to accept the Treasurer's Report for the period ending December 31, 2023, as presented. All voting aye, motion carried.

Moved by Brown, seconded by Hystad, to approve Items 1-6 on the Commission Consent Agenda as presented. All voting aye, motion carried. Items approved: 1. Approve & Authorize Signature 2024 Road Maintenance Agreement – C. Hystad; 2. Approve & Authorize Signature – HUD forms for Hillside Court; 3. Approve Raffle Permits – McKenzie County Ag Expo Foundation – June 14, 2024 & McKenzie County Pheasants Forever – March 23, 2024; 4. Approve Amended McKenzie County Ag Expo

Foundation Operations Agreement; 5. Approve & Authorize Signature – ND Game & Fish – Update to Fish Cleaning Station Maintenance Grant Agreement; 6. Approve Special Alcohol Permit – L&M Office – January 20, 2024 at Ag Expo.

Planning & Zoning Director Kimpel discussed with the Board on the topic of #02-22CUP Revocation of CUP for Brady's Towing. Kimpel provided a timeline of the item. Margaret and Brady Beyers participated by phone and updated on the status of their bond application. Moved by Lawlar, seconded by Skarda, to set the item for final decision on February 6. All voting aye, motion carried.

Emergency Manager Jappe requested permission to attend an out of state training on Clean Waterways in Detroit. Jappe stated she obtained good information from the conference in 2023 and wanted to return again. Questions were asked from the Board about how the information learned was passed on to local entities and encouraged Jappe to provide that information to the Board as well. Moved by Skarda, seconded by Brown, to approve the out of state travel for Jappe to the Clean Waterways conference as presented. All voting aye, motion carried.

HR Director Norby presented information on biannual PDQ reviews that were completed by Gallagher. Norby described the requirement for the review process. Moved by Skarda, seconded by Brown, to approve the biannual PDQ recommendations as presented with an effective date of January 14, 2024. All voting aye, motion carried.

MCWRD Director Perkins requested feedback from the Board on their interest in purchasing property instead of obtaining an easement on an ongoing water project. State's Attorney Skarda stated if the Board is interesting in pursuing this avenue it can be discussed at a future meeting in executive session for negotiations. Board consensus was to continue the discussion and negotiation.

Economic Development Director Stenberg provided an update on the staffing in his department. Discussion was held on a permanent staff member at the Bakken Area Skills Center that would focus on workforce development. This idea is currently being tested out with a six-month contract through Williston State College after which it will be reviewed again.

Trevor Hunter, Crowley-Fleck, presented a request on behalf of Grayson Mills to revise the road improvement template agreement regarding liability language in section 5. The requested changes are being requested from industry. State's Attorney Skarda stated the recommended revision doesn't alter the spirt of the intent and stated he was in support of the change recommended. Moved by Brown, seconded by Hystad, to approve the road improvement template language revision as presented. All voting aye, motion carried.

Moved by Brown, seconded by Wold, to approve and authorize the chairman to sign the Road Improvement Agreement with Grayson Mills as presented for 36th Street NW in Section 5, Township 151N, Range 101W. All voting aye, motion carried.

Engineer Demars presented updates to the County's permitting policies and asked for other input from the Board. Demars stated the policies had been reviewed by the Public Works Subcommittee and industry for their feedback as well. The Board heard from industry partners, who were appreciative of being included in the process and acknowledged the new policies were less stringent and improved their abilities to operate. Demars stated discussions will continue before bringing the policies back to the Board for more discussion and approval.

Moved by Hystad, seconded by Wold, to approve and authorize the chairman to sign Task Order #7 with Ackerman-Estvold for the 2024 Chip Seal Project in the amount of \$59,380. All voting aye, motion carried.

Moved by Wold, seconded by Hystad, to approve and authorize the chairman to sign the letter of support for UGPTI/Ulteig's RFP as presented. All voting aye, motion carried.

Joel Brown, VP & Mineral Services Manager at FIBT, provided an update to the Board on the County's mineral and royalty assets. Brown provided information on what's happening in the industry, impacts to the County's assets, lawsuit updates, and long-term projections.

Matt Lierz, FCI Constructors, and Ag Expo Director Kubal presented the results of the recent sealed bid for a billboard at the Ag Expo. One bid that complied with the scope was received from Indigo in the amount of \$823,768, which does not include electrical expenses. Discussion was held on return on investment with advertising revenue, warranty, life-span, insurance, and location. Moved by Hystad, seconded by Brown, to approve the billboard purchase as presented from Indigo. All voting aye, motion carried.

Kubal provided a general update on past and future events at the Ag Expo. Kubal also stated a pipe had burst after the cold weather, which was going to be discussed with the design team on next steps and warranty. Kubal requested direction on adding individuals to the Hall of Fame Wall and the Board recommended working with the Heritage Park.

Discussion was held on the Ag Expo's mini loader, which has not been functioning well. Kubal stated the vendor had been out and made some adjustments and ordered longer forks and the loader should now perform as intended. Kubal requested to start preparing new specifications and possibly trade off this unit. Kubal with return with specifications when they are prepared.

Moved by Hystad, seconded by Skarda, to execute a letter of intent for a tractor lease at the Ag Expo for the period of December 2024-August 2025. All voting aye, motion carried.

Facilities Supervisor Loughnan presented information on the Rawson Shop Fuel Island project. Loughnan provided a quote for new tanks, which will allow for the tanks and pumps to all be located on the existing pad. The Board requested to see additional bids on electrical work and other tank options and return with additional information.

Landfill Operations Supervisor Meadows presented a request to purchase a new F550 unit for the Landfill, to transfer their current F550 to the Fleet Pool, and trade in a vehicle from the Water Resources Department. The total cost of the new unit after trade would be approximately \$75,470 which includes a flatbed and crane. Moved by Skarda, seconded by Wold, to approve the purchase of the new F550 as presented, including the flatbed and crane with a trade-in of the Water Resources Vehicle presented, to move the current Landfill F550 to the Fleet Pool, and to dispose of the snowplow to the metal pile as recommended. All voting aye, motion carried.

Moved by Lawlar, seconded by Hystad, to approve the bank signatories for all County accounts at all financial institutions as Erica Johnsrud, Michelle Thomsen, Peyman Kadir, and Bellen Coronado as presented. All voting aye, motion carried.

Moved by Skarda, seconded by Wold, to approve the 2024 Off Sale Liquor License for My Little Mexico, LLC as presented. All voting aye, motion carried.

Moved by Skarda, seconded by Hystad, to approve the Auditor/Treasurer Office layout changes as presented. All voting aye, motion carried.

Moved by Wold, seconded by Brown, to appoint Doug Bolken to fill the vacancy on the McKenzie County Housing Authority Board as recommended by the Housing Authority. All voting aye, motion carried.

The Board thanked the Road & Bridge and Maintenance crews for their hard work keeping sidewalks, parking lots, and access open on County properties.

The meeting recessed at 1:40 p.m. until January 17, 2024, at 9:00 a.m.

Special Meeting January 17, 2024

The Board of Commissioners of McKenzie County, North Dakota met for a special meeting at the Commissioners Room at the McKenzie County Courthouse in Watford City, North Dakota on January 17, 2024. Present: Commissioners Joel Brown, Clint Wold, Craig Hystad, Howdy Lawlar, and Kathy Skarda. Also present Auditor/Treasurer Johnsrud and State's Attorney Skarda. Chairman Lawlar called the meeting to order at 9:00 a.m.

The topic of the meeting was to discuss possible cost-of-living, retirement, and pay scale structural changes.

The Board discussed the compensation audits that took place in 2022-2023, buydown of insurance premiums, legislative mandates, and other changes that impacted employee wages in the past year. Options were presented for various cost-of-living increases and various county-paid portions of employee retirements and impacts to employees. Other discussion centered on revenues from the oil industry, possible implications to industry challenges, and long-term sustainability.

Moved by Brown, seconded by Hystad, for McKenzie County to pay 4% of the employee's current contribution to the NDPERS Main and Public Safety plans once approved by NDPERS and for McKenzie County to pay 4% of the employee's current contribution of TFFR with an effective date of July 1, 2024. Employees in the NDPERS Main Plan will be responsible for 3% of their contribution, employees in the NDPERS Public Safety Plan will be responsible for 1.5% of their contribution, and the employee in the TRRF Plan will be responsible for 7.75% of their contribution. All voting aye, motion carried.
