- ◆ Infectious Waste
- ◆ Fertilizers or Pesticides
- ◆ Pipeline Instrumentation Guides, P.I.G.S
- ◆ Hazardous/Radioactive Waste over 5.00 µR/h
- ◆ Hoses 3" and larger (oilfield or industrial or any kind)

1. Campers must have an empty black water tank, **all** appliances removed. Appliances include, but not limited to, hot water heater, refrigerator, stove, AC, microwave etc...

2. Absolutely no **Metal** can go into the Municipal Cell mixed with your garbage. If you drive off and leave metal behind expect to have a metal fee added to your bill.

3. All food waste must be **emptied** out of your fridge or freezer before dumping it on the PDA.

Know What is on your load

or Expect to Pay the Fees.

Rejected Load ¹	\$1,000 Load
Filter Sock or Pit Liners ¹	\$10,000 Load
Loader Fee	\$50 Each
Unsecured or No Tarp	\$40 Load
Metal ² (not sorted out of load)	\$240 load
Pigs or Hoses (left behind)	\$25 Each

Pipes and Wood need to be cut down to 4 feet in length or it will not be accepted. Concrete needs to be about the size of a basketball with no metal.

There are specific places for all of the waste that comes into the McKenzie County Landfill. The scale operator will direct you to these locations. If you have any questions please ask. If you cannot hear what is being said, turn off your vehicle or pull forward and come inside. If we must move your waste to the proper location you will be charged the **loader fee of \$50** and other fees may apply.

Please call ahead if you have something to dispose of that's not listed. Exact prices will not be discussed due to not knowing how much waste you have.

All **Out of County Waste** must be identified by the driver. The loads will be charged an extra **\$10 per ton**. Tickets will be changed accordingly if falsely identified.

Once a load has been compacted or pushed there are no re-funds and no possibility of excavation.

This is a No Salvage Landfill, all waste that is on the property will stay on the property. If caught taking any waste the individual will be dealt with accordingly.

Waste Accepted at the McKenzie County Landfill

- ◆ Household food waste

- ◆ Mattresses
- ◆ Couches or household furniture
- ◆ TV's and electronics (Separated from load)
- ◆ Batteries (Separated from load)
- ◆ Pallets, 2x4's, trees (cut in 4ft sections)
- ◆ Woodchips (Free)
- ◆ Pipes (Not radioactive or contaminated)
- ◆ Clean Dirt (Free)
- ◆ Campers of any kind (Appliances removed)
- ◆ Construction waste (No metal)
- ◆ Household appliances
- ◆ Refrigerators, Freezers, Air Conditioners (Separated)
- ◆ Tires with or without rims of any kind
- ◆ Propane tanks and fire extinguishers
- ◆ Household waste oil (Separated)
- ◆ Deceased Animals (4 hour notice)
- ◆ Burn barrels (Cool to the touch)
- ◆ Dry Paint
